A BILL

To prohibit the use of Federal funds for the commemoration of certain former Presidents, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "No Glory for Hate
- 5 Act".
- 6 SEC. 2. FEDERAL FUNDS RESTRICTION ON COMMEMO-
- 7 RATING CERTAIN FORMER PRESIDENTS.
- 8 Notwithstanding section 3102 of title 40, United
- 9 States Code, no Federal funds may be used to—

1	(1) create or display any symbol, monument, or
2	statue commemorating any former President that
3	has been twice impeached by the House of Rep-
4	resentatives on or before the date of enactment of
5	this Act or has been convicted of a State or Federal
6	crime relating to actions taken in an official capacity
7	as President of the United States on Federal public
8	land, including any highway, park, subway, Federal
9	building, military installation, street, or other Fed-
10	eral property; or
11	(2) name, designate, or redesignate a Federal
12	building or Federal land after, or in commemoration
13	of, any former President that has been twice im-
14	peached by the House of Representatives on or be-
15	fore the date of enactment of this Act or has been
16	convicted of a State or Federal crime relating to ac-
17	tions taken in an official capacity as President of the
18	United States.
19	SEC. 3. RESTRICTION OF FEDERAL FUNDS FOR PROPERTY
20	BEARING THE NAME OF CERTAIN FORMER
21	PRESIDENTS.
22	Notwithstanding any other provision of law, no Fed-
23	eral funds or other Federal financial assistance may be
24	provided to a State, political subdivision thereof, or entity
25	if any such funds or financial assistance will be used for

- 1 the benefit of any building, land, structure, installation,
- 2 or any other property that bears the name, or is named
- 3 or designated in commemoration of, any former President
- 4 that has been twice impeached by the House of Represent-
- 5 atives on or before the date of enactment of this Act or
- 6 has been convicted of a State or Federal crime relating
- 7 to actions taken in an official capacity as President of the
- 8 United States.

9 SEC. 4. FORMER PRESIDENTS ACT RESTRICTION.

- Notwithstanding any provision of the Act entitled
- 11 "An Act to provide retirement, clerical assistants, and free
- 12 mailing privileges to former Presidents of the United
- 13 States, and for other purposes", approved August 25,
- 14 1958 (3 U.S.C. 102 note; commonly known as the
- 15 "Former Presidents Act of 1958"), any former President
- 16 that has been twice impeached by the House of Represent-
- 17 atives on or before the date of enactment of this Act or
- 18 has been convicted of a State or Federal crime relating
- 19 to actions taken in an official capacity as President of the
- 20 United States is not entitled to receive any benefit, other
- 21 than Secret Service protection, under such Act.
- 22 SEC. 5. PROHIBITION OF BURIAL OF CERTAIN FORMER
- 23 PRESIDENTS.
- Section 7722(a) of title 10, United States Code, is
- 25 amended by adding at the end the following:

- 1 "(3) In carrying out paragraphs (1) and (2), the Sec-
- 2 retary of Defense shall not approve a determination of eli-
- 3 gibility for interment or inurnment in Arlington National
- 4 Cemetery made by the Secretary of the Army that permits
- 5 the interment or inurnment in Arlington National Ceme-
- 6 tery of any former President that has been twice im-
- 7 peached by the House of Representatives on or before the
- 8 date of enactment of this Act or has been convicted of
- 9 a State or Federal crime relating to actions taken in an
- 10 official capacity as President of the United States.".
